# E. Legislative Committee – (P. Fantulin, Chairperson)

Status update regarding Legislation:

- S-86 Governor signed legislation allowing school districts to put armed retired law enforcement officers in schools. They must have special training to work in schools.
- A1878/S2404 increases to under \$15,000 from under \$10,000, amount of permitted annual compensation paid to the Teachers' Pension and Annuity Fund (TPAF) retiree reemployed as athletic coach by a former school district within 180 days of retirement.
- A-3662/S-2374 –Rosa-Bonilla Family Act" approved classroom drivers education programs now will have to address carbon monoxide safety education.
- A-3349/S-2438 –Requires annual school security training for school employees to be conducted collaboratively with emergency responders; requires law enforcement officer to annually attend at least one school security drill.
- A-3348/S-2439 This bill takes effect immediately and there are nearly 30 different requirements for school security. Some pertain to new schools and some measures are for existing buildings, as applicable. Of the 19 measures that apply to existing buildings, many of them are things that we already do. Some of them are inapplicable. Some of them are things we might consider.
