 - On May 31, NJ Congressman Jefferson Van Drew announced the drafting of the "Stronger Schools Act," a new legislation that would work in coordination with the Department of Defense to develop a program to train and employ veterans and retired law enforcement officers to become School Resouce Officers, or SROs. The bill also would provide funding for additional security measures and require at least one armed officer be on school grounds at all times. This is a very important issue. We will remain watchful as this bill progresses.
 - On May 12, the Transportation and Independent Authorities Committee advanced the following measures to the NJ State Assembly.
 - a. A-3565 would permit the holder of a valid, non-commercial driver's license, upon completing required training, to operate a Type S school bus to transport students. These drivers would no longer be required to obtain a CDL or school bus endorsement.
 - b. A-1282 would establish a \$45 million dollar, three-year grant program in the state's Environmental Department to determine the operational reliability and cost effectiveness of replacing diesel-powered school buses with electric school buses. The program would select six districts each year, focusing on low-income communities with environmental justice issues.
