BE IT FURTHER RESOLVED, that the GENERAL FUND tax levy \$21,947,181 is approved to support Current General Expense and \$940,300 to support Debt Service, for the 2022-23 school year budget.

Included in budget line 620, Budgeted Withdrawal from Capital Reserve- Excess Costs & Other Capital Projects is \$310,000 for other capital project costs to complete the final phase of the district wide door replacement project and renovations to an art room at the high school. The total costs of these projects represent expenditures for renovation elements or projects that are in addition to the facilities efficiency standards determined by the Commissioner as necessary to achieve the CCCS.

New Jersey School Performance Report – The 2020-2021 New Jersey School Performance Reports have been released and are available on the webpage <a href="www.njschooldata.org">www.njschooldata.org</a>. Performance Reports provide a variety of information about schools and districts. We encourage you to use these reports to:

- Learn more about your school and district
- Start conversations with school community members and ask questions

 Engage with school communities to identify what schools are doing well and where they can improve

It is important to note that the ongoing COVID-19 pandemic has had a significant impact on the way the department was able to measure school performance and student achievement in both the 2019-2020 and 2020-2021 School Performance Reports. While some data that was missing last year is available in this year's reports, such as attendance data, other data continues to remain unavailable or look different from prior years. When the reports are accessed you will find that notes are included to explain where data is missing or impacted by COVID-19.

New features of the reports include:

- New career and college readiness data including Advanced Placement (AP), International Baccalaureate (IB) and dual enrollment participation by student group and work based Learning participation
- Expanded staff data including staff counts and information about teachers by subject area
- New apprenticeship data that shows how many students register in programs after high School graduation
- Links to additional data such as Start Strong assessment results and opportunity to learn Data

More detailed information is readily available on the NJDOE website, and includes information on clubs and activities, student health and wellness, early childhood education, student supports and services to name a few.

MPHS ranked #54 by US News and World Report – MPHS was ranked #54 in the list of top high schools in New Jersey, a ranking that is up from #58 last year. Categories in the ranking calculations included: College Readiness, State Assessment Proficiency and Performance, Underserved Student Performance, College Curriculum Breadth and Graduation Rate.

The U.S. News rankings included data on nearly 24,000 public high schools in 50 states and the District of Columbia. In addition to traditional high schools, the rankings encompass charter, magnet, and science, technology, engineering and math-focused schools.

Congratulations to Mr. Capuano, the entire MPHS staff, and of course, our amazing students for their hard work and commitment which led to this great result.
