District Assessment Report

• Presented by the Administrative Team on the assessment results for SY 2019-2020. In prior years when the traditional mandated assessment program was conducted, this report was presented to the Board and public by NJ public school districts in the fall, following the release of final state assessment score reports. The state assessments were not conducted last spring due to the COVID-19 pandemic, this presentation will focus on other assessment data. We will include information on learning loss and remediation efforts, social-emotional learning and action plans for improvement. While this presentation fulfills the statutory requirements for public reporting of data regarding student achievement, enrollment is low in certain subgroups. While we are required to protect student confidentiality, we will publicly report only that subgroup data where student enrollment meets the identified benchmark.
