**WHEREAS**, the Midland Park Board of Education (hereinafter referred to as the “Board” and the Midland Park Administrators’ Association (hereinafter referred to as the “Association”) are parties to a collective negotiations agreement that covers the 2007-2008 through the 2009-2010 school years (hereinafter referred to as the “Agreement”); and

**WHEREAS**, the parties, by and through collective negotiations, have come to an agreement concerning additional terms for a successor agreement, those terms being specifically contingent upon the parties agreeing to an expiration of the present Agreement earlier than May 21, 2010; and

**WHEREAS**, the parties wish to amend the Agreement accordingly;

**WHEREAS**, the Association has, by a majority vote of its membership, ratified the Addendum to the Agreement well as the new successor beginning on May 21, 2010 and ending on June 30, 2011.

**NOW, THEREFORE, BE IT RESOLVED** that the Board hereby ratifies and approves the terms of the Addendum and the successor agreement, which are attached to this Resolution and made a part hereof; and

**BE IT FURTHER RESOLVED** that the Board hereby authorizes the Board President and the Business Administrator/Board Secretary to execute, on behalf of the Board, the Addendum and the successor agreement by and between the Board and the Association.

3. Approve the Negotiated Agreement between the Midland Park Board of Education and the Midland Park Administrators and Supervisors Association effective May 21, 2010 continuing through June 30, 2011, support material attached.
